# **AUGUST 2024 BENEFITS BULLETIN**



The Benefits Office of Local 13 continues to push through the loss of welfare eligibility madness that happened because of welfare claims not being processed by PMA in a timely manner. Most of the welfare claims that were delayed have been approved. Thank you to all the members who shared their hardship stories of what the loss of eligibility created with their medical and prescription needs.

Remember, if you did not work 800 hours between December 24, 2022 and December 22, 2023 you must submit a welfare claim in order to be eligible for medical/dental/vision/prescription benefits effective July 1, 2024.

The deadline for welfare claims is always May 31<sup>st</sup> every year. If you missed this deadline, it could take up to 6-8 weeks to reinstate your welfare benefits.

This is a photograph of the last six **Full and Fair Review Requests** (FFRRs) that I have written on behalf of members whose chiropractic claims have been denied. They were all written in the past couple of days and I still have several more to write this week. This is in addition to the other FFRRs that I assist members with for other denied claims such as surgeries. It is a long and tedious process that requires a lot of reading and writing, but it is the contractually established process that we must follow. Be sure to include your phone number and brief, but specific details about your situation in the body of the email.

If you are ill or injured, you have three choices when it comes to work:

- 1. You can remain **off work** until you rehabilitate. That is a personal choice between you, your provider, the state disability office (if you qualify), and any supplemental insurance you may have independent of the ILWU.
- 2. You can request to **work with reasonable accommodations** through the Americans with Disabilities Act (ADA) by submitting a valid medical note to the Benefits Office of Local 13 via email or in person.
- 3. You can choose to **work regular duty and self-accommodate** as needed and under the care and guidance of your provider.

- 7. Complete the normal payment process.

- 5. Tickets will be delivered via the AXS app using the email you entered at the time of purchase within 24 hours of when you complete the transaction. The AXS app is free and easy to download.
- 6. Follow the instructions on the AXS app to view and download your tickets using your mobile device.
- 7. This offer is good for only <u>TWO</u> tickets to the game <u>per email address</u>. If you need more tickets, <u>you</u> <u>will need to use a different email address</u>.
