# An Injury To One Is An Injury To All!

## Message From The Secretary-Treasurer By Mark Williams - Secretary-Treasurer

Brothers and Sisters,

Want to continue my article from the last Off the Hook. I quoted from The Dispatcher from January 16, 1959; this article was about the ILWU push for a national health care system. Although the Affordable Care Act isn't the same thing, it's a step in the right direction. Here is a look at what we thought of insurance companies in 1959.

"One type of voluntary health plan that has AMA's blessing, now that millions of people have purchased it, is commercial health insurance. The Health Insurance Institute reported January 2 that some 70 million people have some hospital expense insurance, 67.5 million-surgical, 33 million-medical (meaning for physicians' non-surgical services).

The insurance companies are in the business to make a profit, not to provide health care. Operating for profit, they play no part in furthering the orderly organization of health services. Their activities to promote health, like industrial rehabilitation and health education programs, are to save them money to cut claim costs. The AMA policy matches their own economic interests.

Insurance does help pay some costs of health services, but:

Emphasis is on hospital and surgical expenses. Well over half of our health bills are for non-surgical services outside of hospitals. This emphasis has sideeffects. When a patient has hospital insurance only, he may get put in the hospital for something that could be diagnosed or treated as well or better in the doctor's office. Then what the insurance company pays out rises, premiums go up, and meanwhile someone who really needs hospital care may not be able to find an empty hospital bed."

Those 202 words spell out generations of care, or lack of it. No matter how you feel about the current state of our own benefit plan, we have it better than most. There will be a battle this contract for the MOB (maintenance of benefits) and for further gains! I will continue to show you how relevant our past is to our future so that you can share the fight the past members of the ILWU had. Remember sisters and brothers we work because of and for those who came before us. Look out for one another and stand together. Please take the time to think about what "An injury to one is an injury to all "means".

## Health Benefits Are You Happy? Are You Satisfied? I'm Disappointed!! By Jerry Avila - Health Benetits Officer

### Brothers and Sisters,

n light of the recent decision on May 5, 2014, by John Kagel, the Coast Arbitrator, to retain Zenith American Solutions as the Third Party Administrator of the Plan (TPA). Let us not forget! It was the plan consultant, Milliman who was not able to make a decision on (TPA) in the first place. The decision for a (TPA) was between the Union's choice: BENESYS or the employer's choice: Zenith American Solutions.

At the Arbitration, the union gave the facts' testimonial (including mine) in the hopes that the arbitrator would replace Zenith American Solutions with the *UNION'S CHOICE*.

The Decision was left up to John Kagel, Coast Arbitrator as Impartial Umpire: *"From this record,* Zenith is, under the circumstances shown, at this time, fulfilling the requirements of the RFP, subject to further review by the Trustees as time goes by".

Negotiations opened up on May 12, 2014 and among one of the key issues is: *MAINTENANCE OF BENEFITS*.

We have to look at what the immediate future holds for you, the membership, first and foremost and protecting yourself from potential problems with Zenith American Solutions. Even though you all have the ability to be treated by whatever medical provider you choose, what we do know is those claims coming from "in network" providers have the least difficulty getting processed and paid.

Along those same lines **DO** NOT assume that your "in network" provider will refer you to "in network" providers for other services. If they refer you for anything outside their office; such as blood work, diagnostic testing (MRI's, CT Scans, X-rays, etc.), to see a specialist, or for other treatment such as; surgery, physical therapy etc. your very first question to them should be: "Is that provider in network?" If they are not, you may request a referral that is "in network" or use that provider knowing that it will be paid at the 80/20 of Maximum Allowable Charges (MAC) rate.

Please check your Explanation of Benefits aka: EOB. Read the "Remark Code" column and its explanation under the boxes to understand what status your claim is in. We know these can be confusing to understand and *at some point in the near future a workshop will be held to help you understand your EOB(s)*. Until that time, if you have questions, please contact ILWU Local 13; Sam Alvarado (310) 833-5144 office or the ILWU/PMA Benefit Plans office in San Francisco at (415) 673-8500.

If your claim(s) has (have) been denied and Zenith is informing you that your only option is to ask for an appeal you (not your provider) must request in writing the first step of the appeal process for a Full and Fair Review and mail to the ILWU/PMA Benefit Plans Office, 1188 Franklin Street, Ste. 300, San Francisco, CA 94109. You should address your letter to the Trustees of the plan, attention: Mario Perez, Welfare Manager.



## Trustee Report By Chris Casíillo - Trusíce

want to begin by acknowledging all of the brothers and sisters in our Local that pay their dues, fines, and assessments timely. Thank you for being members in good standing.

We have had an ongoing issue at Local 13 for quite some time involving Grievance Fines. The existing problem is people simply refusing to pay their fines which ultimately forces us to use union resources to collect the money. The main purpose of the Grievance Committee is to aid in the enforcement of the Union Constitution and By-Laws, rules, and regulations. These committee members volunteer their time serving the local and its time we start to take this process seriously. I want to remind everyone that we are all on the same side. The Trustees are not the bad guys, we are doing the job we were elected to do; which is financial responsibility and accountability of union funds.

There are a number of options for paying these fines which do not have to be paid all at once. The Local is flexible and will work with members, but members have to make an effort to pay. It is not fair the majority pays their fines and others think they do not have to.

The Trustees are going to coordinate with Legal Counsel and the Grievance Committee to initiate small claims cases against members delinquent in fines. Once again, there are payment plans for all situations as long as an honest effort to pay is made. If no course of action is taken from the member to pay, you will receive a letter stating that you have to attend small claims court. We do not want members to miss out on a day's work in order to attend court so please get to the Dues office, and do your due diligence. You will not be eligible for training or transfer if you are not a member in good standing.

### Let's work together and protect Local 13 and our Grievance procedure as union members!

ecently, the United States Supreme Court struck another blow to the integrity of the American political process. Once again, the Supreme Court has put our nation's democratic process on the auction block in another 5-4 decision split along ideological party lines.

In the latest decision, McCutcheon v. FEC, the Supreme Court struck down the aggregate limits on what individuals can contribute in federal elections. To explain in greater detail, under federal campaign finance law, individuals were limited to giving a combined total of \$123,200 in a two-year election cycle. Of that total, individuals could give \$5,200 to each candidate up to a combined total of \$48,600 and \$74,600 to all political action committees and parties. Under the guise of "free speech" the court struck down the limits on the aggregate sum that an individual could give. This means that even though donors are still limited to the \$5,200 per candidate cap each election cycle; the total amount they can give is unlimited. For example, prior to the Supreme Court decision, a wealthy donor could only give a \$5,200 contribution to nine separate candidates. Now, that same wealthy donor could give a \$5,200 contribution to every politician up for re-election. "Free Speech" sounds pretty damn expensive...

Four years ago, the Supreme Court opened the election process to a flood of special interest money with the *Citizen's United v. FEC* decision. *Citizen's United* allowed corporations and unions to spend unlimited amounts of money for



"independent expenditures". An independent expenditure is an expenditure for a communication "expressly advocating the election or defeat of a clearly identified candidate that is not made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate's authorized committee, or their agents, or a political party or its agents." The court's decision overruled precedents set in previous Supreme Court decisions and struck down the McCain–Feingold Act, a bipartisan law passed in 2002 that aimed at reforming federal campaign financing.

Both Citizen's United v. FEC and McCutcheon v. FEC were 5-4 decisions. When you look at the majority in both cases it easy to figure out who benefits. The five justices that were responsible for these decisions are from the court's conservative wing and were all appointed by Republican presidents: Anthony Kennedy and Antonin Scalia were both appointed by Ronald Reagan, Clarence Thomas was appointed by George H.W. Bush, and both Samuel Alito and John Roberts were appointed by George W. Bush. These five lifetime appointees overturned laws passed by a democratically elected congress to allow their political cronies to buy elections. Men like fiercely anti-union casino mogul Sheldon Adelson, who spent a whopping \$93 million on the 2012 election and the well-known Koch brothers, who are already spending millions of dollars through their Super PAC, Americans for Prosperity, to defeat vulnerable democrats in Senate races around the country. In a frightening revelation, Justice Clarence Thomas stated in part of the majority opinion that he's in favor of removing even limits on individual contributions to candidates, allowing wealthy donors to give as much money as they want directly to politicians that will do their bidding. This shows how far certain ideologues on the Supreme Court are willing to go in order to further their party's agenda.

While there is no doubt that the money pouring into politics is being spent on both sides, the fact is the four Supreme Court Justices appointed by Democratic presidents, Bill Clinton and Barack Obama, opposed the Republican appointed majority that issued these decisions. In the aftermath, Republican politicians have hailed these decisions as victories for the 1<sup>st</sup> amendment

and Democrats have almost universally derided them as a corrupting influence to our political process. It should also be noted that the petitioners in each case, Citizens United and Shaun McCutcheon, both serve conservative interests. Citizens United is a non-profit organization that produced the highly critical Hillary Clinton documentary, *Hillary: The Movie*, and Shaun McCutcheon is a conservative businessman from Alabama who was joined by the Republican National Committee in his case against the FEC.

As elections become more and more influenced by money unions must fight fire with fire. Unions need to use their resources to outspend, outwork, and outmaneuver anti-union candidates. Unfortunately, many American workers, including union workers, have bought into the old tired stereotype that unions are run by a bunch of corrupt mobbed-up thieves. This rhetoric is part of an 80-year propaganda campaign to destroy the credibility of unions and erode union support. Sadly, the propaganda has worked. Unions have gone from representing 35% of the workforce at their peak, to currently representing less than 12% with the numbers continuously declining. Look at those numbers from another perspective. In 1955, if you were standing in a room with a total of ten people, more than likely almost half the people in that room would belong to a union. Today, in a room with ten people, you'd be standing alone as the only union member. That is a microscopic analogy of what's happened to the American work force in the last 50 years.

The only way for unions to survive is to win back public support. We can only accomplish this by increasing our ranks. In order to increase our ranks we must shift the balance of power back to an even keel. That balance of power can be shifted by changing the law to make it easier for unions to organize and giving unions more leverage in collective bargaining. The only way to achieve this change is to elect politicians that understand how important unions are to the middle class. To get elected, those politicians must be well funded. Each and every union member needs to contribute to their organization's Political Action Fund. The Supreme Court has turned free speech into a spending spree. Charles Koch and Sheldon Adelson aren't going to stop dumping millions of dollars into elections, and if unions don't have skin in the game our voice won't be heard.

# MOMENT OF SILENCE FOR OUR FALLEN BROTHERS May 15, 1934

loody Thursday, July 5 is the day the union commemorates the loss of the six union men (two in Seattle, two is San Francisco and two in Wilmington) who died in the union's bitter struggle to win the 1934 strike.

Shortly before the strike began on May 9<sup>th</sup>, a vote was taken and 97% of the Longshoremen chose to be represented by the International Longshoreman's Association. We became ILA Local 38-82. The Employers ignored that vote and signed a sweetheart contract with a company union called Longshoreman's Mutual Protective Association. The Los Angeles Police Department fully and openly, funded by the Employers, became an armed, strike- breaking force with the duty of protecting the growing number of workers who crossed the picket lines. Scabs on the waterfront were fed and housed in waterfront tent encampments called bullpens.

Late on the night of May 15<sup>th</sup> a group of unarmed union men, frustrated by scabs working and sailing ships, decided to break up the Neptune Avenue's West bullpen at the Berth 145 Grace Line Terminal. Heavily armed police met the union strikers. During a tear-gas filled melee six union men were shot. Twenty-year old Richard J. Parker from San Pedro, who had joined the ILA the previous day, was fatally wounded. John Knudsen, age 51, died in the hospital of his bullet wound on June 5<sup>th</sup>.

Our Brothers were the first men to give their lives in that strike. We commemorate all of our Union's deceased on a no workday, July 5<sup>th</sup>, however, May 15<sup>th</sup> is a normal workday. We should not forget what happened that day. To honor and remember **Dickie Parker** and **John Knudsen** this May 15<sup>th</sup>, during both the day and the night dispatch, the Chief Dispatcher will lead us in a moment of silence.

ry to imagine this if you will. You purchase a home, you live in that home for a long time, and you come home from work one day to find the locks on your doors have changed. The bank that still owns your house and negotiated your loan is standing outside with the local law enforcement agency The government and the mangers of the bank are there to inform you that you are no longer welcome in YOUR house! Then much to your stunned disbelief they invite others to come live in your house at a much reduced price. Sounds impossible or surreal right? Well it is possible. And it has happened right here in America. The unlawful and morally reprehensible lock-out of ILWU workers at the grain terminals in Vancouver, WA on February 27, 2013 and Portland, OR on May 4, 2013 are just two of the many recent injustices perpetrated on American workers and the middle class.

The lock-out of ILWU workers in Vancouver has cost local 4 approximately 40 to 50 jobs. In Portland another 50 jobs have been lost at Local 8. The reluctance of the large foreign-owned grain companies to bargain in good faith and offer a fair and reasonable contract has been equally offensive as the lock-out itself. It is for this reason that local 13 has pledged their support recently in the form of "man power". I and Jerry "Scrub" Sanchez traveled up north on April 16, 17, and 19. Then, on the

Anniversary of the lock-out at Columbia Grain terminal in Portland on May 4, eleven Local 13 members and one very militant local 94 member traveled again to show our support, help lift spirits and moral, and show our solidarity. In short, it has been a great success. Portland and Vancouver ports have welcomed us like saviors of stranded desert islanders. We disrupted movement of scab labor to United Grain terminal in Vancouver for about 75 minutes on one of the days. Our presence at every other shift change delayed all scab labor in and out of the gate. Local Vancouver police were called and this eventually ended in the arrest of one of our members. Two other members were also ticketed. All three of these charges basically stem from an American citizen simply exercising their constitutional rights to free speech and peaceful demonstration.

I'd like to make one thing clear in closing. This is "Our" struggle. Please don't think of this as "This could happen to us." This is us. We are, and we represent organized labor throughout the world in one way or another. Thanks go out to all the brothers and sisters that who traveled up north to support our struggle. And, thanks to our President, E-Board, and membership for continued support.
